COVID-19 VACCINATION INFORMATION & DATA UPDATE

The Barren River District Health Department has confirmed a total of 28,189 cases, 25,630 of which have recovered. We have 388 deaths reported from COVID-19. We stand in solidarity with those affected during these difficult times. See the breakdown of numbers by county below. Please note that a decrease in numbers is due to the county of residence or case status being corrected/updated from what was previously reported.

The Barren River District Health Department is currently administering COVID-19 vaccine for individuals in Phase 1C. Effective March 8, 2020, our agency will schedule appointments for mid-March through the end of March for individuals in Phase 1C. Due to vaccine supply, vaccine clinics will occur on specific days for each county. Once the appointments are full for March, we will schedule appointments again in late March for the month of April.
